The Government of Uganda (GoU) has received financing from the International Development Association (IDA) of the World Bank in the amount of US\$135 million equivalent towards the cost of Uganda Energy for Rural Transformation Phase III (ERT III) and it intends to apply part of the proceeds to payments for the Supply and Delivery of Three (03) Double cabin Pickups and One (01) Station Wagon.
2. The Entity invites your sealed bid for the Supply and Delivery of Three (03) Double cabin Pickups and One (01) Station Wagon.
3. Bidding will be conducted in accordance with the National Competitive Bidding method contained in the as specified in the World Bank's Guidelines: Procurement of Goods, Works and Non Consulting Services under IBRD Loans, by World Bank borrowers January 2011, Revised 2014.

Bidding documents in English may be purchased on the submission of a written application to the address below at 7 and upon payment of a non-refundable fee of Uganda Shillings: One Hundred Thousand Only (UGX: 100,000). The method of payment will be cash at the REA Accounts Offices in the *address in 7 below*.
6. Bids must be delivered to the address below at 7 at or before 19th October, 2017 at 11:00am (local time). *All bids must be accompanied with a bid security of Uganda Shillings: 10,000,000 (Uganda Shillings: Ten Million) only*. Late bids shall be rejected. Bids will be

opened in the presence of the bidders' representatives who choose to attend at the address below at 7 on 19th October 2017 at 11.15 a.m. (local time)
